## What personal data do we collect about you? How will we use that personal data?

# What is our legal basis for processing your personal data?

We need a legal basis in order to process your personal data. Most of our processing is done because we have a legitimate interest in doing so.

We will process the following personal data because we believe that we have a legitimate interest in doing so: your personal data provided when you give us your business card or email one of our employees or inboxes. Our legitimate interest is furthering our business relationship.

You have the right to object to our processing your data using legitimate interest. Please speak to us if you have any concerns.

## Do we use any automated decision making?

We do not use any automated decision making.

# Who do we share your personal data with?

We share your data with:

- Our software providers, (including Salesforce, Sage Accounting)
- Clients looking for workspace if you are a workspace provider / Landlord who is registered to use our service
- Cloud service providers



#### Do we transfer your personal data outside of the EU or EEA?

We do not transfer your personal data outside of the EU.

#### How long do we keep your personal data for?

We will hold your data for as long as you remain a contact for our mutual or future business. We will delete it is you are no longer a contact or request for us to do so and we don't need it anymore. If you are no longer the most appropriate contact then please let us know.

## Your rights as a data subject

The GDPR gives you rights as a data subject. You have:

- the right to request from us access to your personal data;
- the right to request from us rectification of your personal data;
- the right to request from us erasure of your personal data;
- the right to request from us restriction of processing your personal data;
- the right to object to our processing of your personal data;
- the right of data portability;
- if we are processing your personal data on the basis of your consent, you have the right to withdraw your consent at any time. This does not affect the lawfulness of processing based on your consent before you withdrew it; and
- You have the right to complain to the ICO.
